

**NOTICE WITH REGARD TO PERSONAL DATA PROTECTION PURSUANT TO ART.
12 AND FOLLOWING ARTICLES, REGULATION (EU) 679/2016**

Pursuant to the new Regulation (EU) 679/2016, in compliance with the principle of responsibility undertaking any processing of personal data shall be lawful, correct and transparent. Such principles imply that the data subject shall be informed about the existence of the Regulation and its purposes, and about the rights he or she can exercise.

RETENTION PERIOD

RIGHTS OF THE DATA SUBJECT

Under the law provisions in force, the data subject can address the Controller to lodge a request for exercising his or her rights, such as they are stated to art. 15 and following in the Regulation (EU) 679/2016.

In addition to the above mentioned rights, the data subject has the right to lodge a complaint with the Supervisory Authority in the instances envisaged by law.
